Draw Hunting Summary For the TMA :

Drawing hunts require an application fee and are awarded by lottery. Each year, the Alaska Department of Fish and Game (ADF&G) publishes a Draw Hunt Supplement with specific information containing the drawing hunt opportunities and area boundaries.

When to Apply:

The next application period for Draw hunts will be November 1st – December 15th, 2023. Applications will only be accepted online.

How to Apply for Draw Hunts:

Hunt number for the TMA is DS102(Aug.10th - Sep. 20th)

You will need to purchase a valid hunting license if you do not already have one. **Be sure to print as this is the only copy you will receive.**

- **(Be sure to write Matthew Snyder in as your registered guide and include only up to six hunt numbers for your choices. You may apply all six for the same hunt number)**
- **Non-resident hunters are also required to have a signed Guide-Client Agreement prior to applying for certain hunts. Go to:**
