Drawing hunts require an application fee and are awarded by lottery. Each year, the Alaska Department of Fish and Game (ADF&G) publishes a Draw Hunt Supplement with specific information containing the drawing hunt opportunities and area boundaries.

When to Apply:

The next application period for Draw hunts will be November 1st – December 15th, 2020. Applications will <u>only</u> be accepted online

How to Apply for Draw Hunts: Hunt numbers for the TMA are DS102(Aug.10th - Aug.25th) and DS103(Aug.26th - Sep.20th) My current Unique Verification Code (UVC) for 2020 21YUvhtUVC (must be entered exactly!)
